The bond and credit card facility was financed through Commonwealth Bank of Australia. This facility is denominated in Australian dollars and is secured against cash deposits of the same amount shown as restricted cash in Item 5.4 of this report. An annual performance bond fee is charged at market rates. The facility drawn down at 30 June 2017 was \$0.38M. No amounts are payable under this facility, other than the annual fee, unless the consolidated entity does not adhere to the terms of the agreements guaranteed.

The asset purchase facility was financed through Westpac Banking Corporations. This facility is denominated in US dollars and is translated into Australian dollar at the exchange rate on 30 June 2017. The average interest rate on the facility is 3.074%. At the end of the lease term the consolidated entity acquires ownership of the assets purchased under financing arrangements.

The facility drawn down at 30 June 2017 was \$0.08M which are secured against cash deposits of the same amount shown as restricted cash in Item 5.4 of this report.


