This facility is denominated in Australian dollars and is secured against cash deposits of the same amount shown as restricted cash in Item 5.4 of this report. An annual performance bond fee is charged at market rates. No amounts are payable under these facilities, other than the annual fee, unless the consolidated entity does not adhere to the terms of the agreements guaranteed.</p> <p>In September 2020, the Company announced it had received credit approved terms sheet from two Tier-1 international banks, BNP Paribas and Société Générale (Financiers) for A\$55 million. The Financiers had been formally mandated with next steps including legal due diligence, documentation and completion of conditions precedent prior first drawdown.</p>
