	<p>The Company has a bond, credit card and procurement management facility financed through Commonwealth Bank of Australia with a limit of \$295,000. This facility is denominated in Australian dollars and is secured against cash deposits of the same amount shown as restricted cash in Item 5.4 of this report. An annual performance bond fee is charged at market rates. No amounts are payable under these facilities, other than the annual fee, unless the consolidated entity does not adhere to the terms of the agreements guaranteed.</p> <p>In March 2021, the Company executed a Syndicated Facility Agreement ("SFA") for A\$55 million with two Tier-1 international banks, BNP Paribas and Société Générale ("Financiers").</p> <p>On 7 September 2021, the Company announced it had received a Credit Approved Terms Sheet from BNP Paribas for a new A\$30.0 million Revolving Credit Facility, which will replace the existing SFA. Formal documentation is expected to be completed in the December 2021 quarter.</p>
