This facility is denominated in Australian dollars and is secured against cash deposits of the same amount shown as restricted cash in Item 5.4 of this report. An annual performance bond fee is charged at market rates. The facility drawn down at 31 December 2017 was \$0.44M. No amounts are payable under this facility, other than the annual fee, unless the consolidated entity does not adhere to the terms of the agreements guaranteed.

The facility drawn down at 31 December 2017 was \$0.44M which are secured against cash deposits of the same amount shown as restricted cash in Item 5.4 of this report.



Bacchus has elected to proceed with the Second Option whereby it can increase its interest in the Tottenham tenements to a maximum of 30% by continuing its exploration expenditure to a cumulative total of A\$700,000 (for full details, refer to Mincor's ASX release dated 17 February 2017).
